

PROGRAM DESCRIPTION

Many common ENT conditions can be managed at the primary health care level with the potential for decreasing the financial burden on patients and hospitals. This reduces referrals as well as improving quality and timeliness of care. Using realistic learning experiences, demonstrations, and hands-on skill building techniques, this workshop provides an appreciation of allergy testing, hearing loss screening, Osteopathic Manipulative Therapy (OMT) for common ENT conditions, and an opportunity for advanced level training in flexible nasolaryngoscopy. Attendees shall meet requirements for the Certificate of Proficiency in flexible nasolaryngoscopy and obtain a continuing medical education (CME) Certificate of Completion. An option to meet requirements for the CME Certificate of Completion only is also available.


